RULES AND REGULATIONS OF THE TRUST

1. The trust shall be called " KUNJARU MEMORIAL CHARITABLE SOCIAL WELFARE TRUST"

2. Definition:

a. TRUSTEES mean : the trustees of the fund for the fund for the time being appointed by the Trust Deed or afterwards.

b. THE DEED means : the Trust Deed dated 8.11.2012... executed by the Trustees of the fund.

c. FUND means : the Trust fund constituted by the Trust Deed AND ACCRETIONS THEREIN FROM TIME TO TIME.

d. BOARD means : board of trustees for the time being.

BOARD OF TRUSTEE AND THEIR POWERS

1. The management and the control of the trust and the Trust properties shall vest in the Board of Trustees.

2. The Board of Trustees shall comprise of not less than 3 (three) and not more than 9 (nine).

4. The Board of Trustees will have full and confirmed power to regulate and manage the affairs of the Trust and of any institutions established by the trust as it may establish pursuant to these presents.
5. The Board of Trustees shall have a regular Chairman and in his/her absence a Chairman will be elected at each meeting who shall be a member of the Board.
6. **SUMA GOPALAN** shall be first Chairman and shall continue in his post as long as he wishes. When the post fall vacant the trustees will elect their Chairman with the majority of 2/3.
7. The meeting of the Board of Trustees will be held as often as many necessary from time to time in accordance with the requirement of business in this behalf provides a meeting of the Board of trustees shall be held at least after a three calendar months. Reasonable advance notice in writing of each ordinary shall be delivered or sent by post to each trustees at his/her usual address.
8. The meeting of the Board of Trustees shall be arranged to be summoned by the chairman same day to be fixed by him 3 (three) months from the date hereto.
9. The Chairman may at anytime shall on receipt in writing of any two Trustees specifying in such request the objects of the meeting, summon a special meeting.
10. Every matter shall be determined by majority of the trustees present and voting. The Chairman shall have a casting vote whether or not he/she shall have previously voted on the same question.
11. Any resolution of the Board of Trustees circulated to all trustees, who may be in India and approved by at least 2/3 of them shall be as valid and effectual as it had been passed at any meeting of the Board of Trust duly convened and constituted.
12. The Trustees shall have powers to determine as to whether out of income or capital any expenses or outgoing shall be ought to be paid or bone and every determination shall be binding and conclusive. Provided that nothing herein contained shall be deemed to authorize the trustees to spend the income o f the trust fund for any purpose not authorized by these presents.

i. To appoint any one amongst them as managing trustees with such powers as may be delegated to him/her from time to time.

ii. To permit any or more trustees to operate on any banking accounts without any liabilities on the other trustees, to examine the said accounts or to be in all way responsible for the acts, deeds or defaults of such trustees or trustee in connection with such accounts.

iii. To purchase, construct or hire or take on lease any immovable or movable property for all any other purpose of the said trust such price cost or retain with or without, on such terms and conditions and fro such period and proportion for removal as the trustee my think fit.

iv. To let out lease mortgage, charge or license any property belonging to the tryst for such rent or compensation and on such terms and conditions and for such period the trustees may think fit.

v. To delegate any power of Attorneys or otherwise to any trustees or trustees or any other person or persons implied by the law or conferred by statue or vested in the trustees by these presents by the trustees shall not be held liable or responsible for the acts or defaults of any such persons but only their own respective acts and defaults.

vi. To set up one or more managing committees for the routine and day to day management and administration of any such institutions under their ultimate supervision and control. Trustees may cancel any time any type of managing committees of any particular activity.

vii. To frame such rules and regulations for the managements and administration of trust and regulations as they shall think fit and to alter or vary the same from time to time and to make new rules and regulations. Provided that such rules and regulations shall not be inconsistent with the terms of these present.

- viii. To borrow or raise any money that may be required by the trusts for the achievements of its objects upon such terms as may be deemed advisable and in particular by such bonds, debentures, bills of exchange promissory notes or by mortgage or charge of all or any part of the trust.
- ix. To amalgamate the trust with any other trust or society institution or body having objects similar to those of this trust.
- x. To make any other provisions of these presents as a trustees may be required to make by the income tax authorities as a conditions for recognizing the trust for the purpose of section 80-G and 11 of the Income Tax 1961 of any statutory modification on reenactments thereof the time being in force but without prejudice to the main objects of the trust (a) provided that no such amendment shall be valid unless approved by all trustees for the time being by unanimous resolution passed at their meeting (b) provided that the trustees may in their absolute discretion decide not to seek or avail of the benefit of the sole actions and consequently they may not make any amendments suggested by the Income Tax Authorities.
- xi. To become the member of any other bodies of persons, associations of persons, institutions, societies and bodies cooperate including companies limited by guarantees of the benefit of the trust.
15. A trustee shall be at liberty to retire from the trust or these presents voluntarily and he insolvent or lunatic or becomes off unsound mind provided further that a Trustee shall also retire if so requested in writing by all the other Trustees for the time being in office and also constituting the majority of the Board.
16. The Board of Trustees shall cause to be kept proper books of accounts with respect to all sum or moneys received and expended by the Trusts and of the properties for the time being vested in them and all liabilities in connection herewith.
17. The Balance Sheet and Income Expenditure Account of the Trust shall be prepare by the managing Trustee/Secretary and audited once every year by a recognized firm of Chartered Account. Auditors to be appointed by the trustees and laid before the Board of Trustees at a meeting to be held as far as possible not later than nine months of the date unto which the said accounts have been made.
18. The trustees have authorized to invite or accept donations of money, share debentures, bonds, securities, business and other movable or immovable property from the legacy as think fit.

 - v. To accept and issue receipts fro money received by the trust.
 - vi. To execute power of attorney in favour of professional such as lawyer, Chartered Accountants, Solicitors etc in connection with Trust Fund and matters related thereof and paid them such enumerations as thinks fit.
 - vii. To spend money for the object of the trust.
